i. Village Drainage:

Drainage - it is understood that the containment tanks installed near to the Treatment Plant and the tanker movements for emptying them will be permanent until the new scheme is scoped and completed.

Pond - Cllr Hunter has submitted a request to Yorkshire Water that the Consent to Discharge be removed as it is unacceptable having sewage being discharged into a village pond. He has urged that the two schemes are looked at jointly so as to ensure that there is no possibility of sewage discharges into the pond in the future.

Cllr Hunter has also requested an update on the progress of the planning of the proposed schemes for the drainage and the pond including an expected timeline. To date, he has not received a response to any of his enquiries.

Cllrs Hunter and Goddard arranged for the edge of the pond to be flailed. This has now been done.

ii. Solar Farms: update - objections to the saturation of proposed solar farms in the area has been submitted.

iii. Footpaths - Community Payback Team: update - Cllr Hunter has not had a response. He will re-email the Supervisor. **AH**
